April 4th will be the first day of practice for the new fiscal year. Please read the registration materials, as a new rate structure has been adopted. CIA will have a registration table April 4th- 6th at practice to assist with registration.

Swim Groups

Central Iowa Aquatics (CIA) is a USA year-around competitive swim team designed to improve the level of competitive swimming in the central Iowa area. 2007-2008 Swim Year

Below is the pre-competitive, competitive, and master's swim year. The swimming year is divided into four seasons that correspond, with the Iowa USA Swimming seasons and the Iowa Boys and Girls High School swim seasons. The practice schedule for each of CIA's swim groups are posted on the CIA website at www.centraliowaaquatics.org. Practices are subject to change. Payment Options

- **Annually:** Option only available for April 1 – March 31st. Payment is due by April 15, 2007
- **Seasonal:** Paying the seasonal fee requires a commitment to swim the entire season. Payment is due at the beginning of the season in which a swimmer plans to swim. The swimmer has the option to pay the seasonal rate in two equal payments. The first payment would be due on the first day of each season, with the second payment due 30 days after the beginning of the season. (Example, a senior swimmer swimming the spring season would have the option to pay \$150.00 on April 4th and \$150.00 on May 1st).
- **Monthly:** Paying the monthly fee is for those swimmers who cannot commit to an entire season. A monthly fee is due the 1st of each month the swimmer plans to participate. Payments are not collected in March or August
- **USA** registration fee is due at registration. The registration fee is not required for the pre-competitive swim group

New Swimmer Discount

- For the 2007 –2008 season, CIA is offering a discount of 50% off the monthly rate for a new age group or senior swimmer only. The swimmer will receive 50% off the monthly rate for the first two months the swimmer swims. **This is for new age group or senior swimmers only and can only be used once.** If a swimmer swims one month and quits they do not qualify for an additional month at a later date. Those months must be consecutive.

High School Program

- High school swimmers will still have the option to practice with Coach Dave during their high school season, one night a week at Central after CIA's competitive team is finished. The High School Group is the same as the Senior Group, except a swimmer does not participate in regular practices during high school season. High school swimmers swimming and/or competing with CIA during their high school season need to have approval from the high school coach and/or athletic department.

Payment Policy

- CIA registration fees must be paid prior to participation in CIA activities.
- Swimmers without a signed and paid USA Swimming registration are prohibited from entering the water for insurance purposes. This must be done on a yearly basis. (Pre-competitive swimmers are exempt from this policy except for USAS meets).
- All payments are due on the first of the month. A 15-day grace period is provided. A \$5 late fee is assessed after the 15th. After 30 days, the swimmer will not be able to participate in CIA activities until all past fees are paid plus \$25.

Financial Assistance

The CIA parent board has made an effort to assist families with financial needs. The board will make every attempt to help families with the cost of swimming. However, due to the limited amount of funds available, we will only be able to provide assistance to a limited number of swimmers. Family Discount

Families with three or more swimmers are eligible for a discount. The registration fee for the third and additional swimmer beyond three will be reduced by 50%. The reduction will apply to the lowest registration fees.

Refund of CIA Registration Fees

- USAS registration may not be refunded.
- Monthly fees are not refundable.
- Refunds of the annual registration fee and seasonal fee will be prorated based on the monthly rate.
- Please put requests for refunds in writing and mail to CIA Business Manager.
- There will be no refund of fees for any new swimmer participating in the ½ price trial.

Participation Agreement and Waiver/Release of Liability

Please read carefully before signing. This is both a participation agreement and a release of liability and waiver of certain legal rights.

- The enrolled participant and the parent/guardian of the participant agree and understand that swimming is a hazardous activity. I recognize that there are risks inherent in the sport of swimming, included but not limited to, paralyzing injuries and death.
- The participant hereby agrees to indemnify and hold harmless CIA, its coaches, officers, directors, agents, and employees against any liability resulting from any injury that may occur to the participant while participating in any of the swim programs offered by CIA. The participant also agrees to indemnify CIA for any damages incurred arising from any claims, demand, action or cause of action by the participant.
- The participant authorizes any representative of CIA to have the participant treated in any medical emergency during their participation in any of the swim programs offered by CIA. Further, the participant and/or parent/guardian agree to pay all costs associated with medical care and transportation for the participant.
- I have noted on the back of this form and notified the head coach of any medical/health problems of which the staff should be aware of.
- CIA registration fees must be paid prior to participation in CIA activities. All payments are due on the first of the month. A 15 day grace period is provided. A \$5 late fee is assessed after the 15th. After 30 days, the swimmer will not be able to participate in CIA activities until all past fees are paid plus \$25.
- Swimmers without a signed and paid USA Swimming registration are prohibited from entering the water for insurance purposes. This must be done on a yearly basis. (Pre-competitive swimmers and High School Prep swimmers are exempt from this policy except for USAS meets).
- New members may have a two month new swimmer discount. After that time period, CIA payments will be expected, either monthly or seasonally, and any USA fees will be due.
- I grant permission for my child to participate in the Central Iowa Aquatics activities. I agree to CIA policies as stated in the CIA handbook and registration information
- I have carefully read the above participation agreement and liability release and sign it with full knowledge of its contents and significance.
- I will allow CIA to take a picture of my child for identification purposes.
